**Stichting ABC**, a foundation with legal personality established under Dutch law, whose official seat under the articles of association is in Amsterdam and whose offices are in (....) Woerden, at ....., duly represented herein by its General Managing Director [*Algemeen Directeur*] Mr D.E.F. Jones, hereinafter referred to as '**ABC**';

and
