N.B.2 The shorter regular courses – i.e. all regular courses except the regular yearlong D-E / E-D Legal Translation Course and the regular yearlong D-E / E-D General Translation Course – can also be held on request, provided that there are at least three participants.

N.B.3 If you enrol for one of the courses in the months June to August, a summer discount of 10% applies (this applies to all courses); this discount applies only if the student pays the fee in full at the start of the course.
