N.B.2 The shorter online courses – i.e. all online courses except the yearlong D-E / E-D Legal Translation Course and the yearlong D-E / E-D General Translation Course – can also be held on request, provided that there are at least three participants.

N.B.3 In addition to the courses indicated above, online or written tailor-made courses can also be organised, the frequency of sessions/assignments and the content of the programme being determined in consultation with the participant(s).
